Lead Window Replacement program

Sparc is now offering a program to homeowners that will pay for half the total cost tp replace windows containing lead paint. In order to qualify for the program, you must meet the following qualifications:

- A child under the age of six (6) must live in the home.
- The windows must contain lead paint.
- The owner occupied home must be in Como, the North End or South Como neighborhoods.
- The household must earn less than 80% of the Twin Cities area median income.
- The chart below shows the maximum gross income limit based on household size.

District 10 Environment Committee

Looking back – and moving forward...

2006 was another busy year for the Environment Committee. David Arbeit continued to serve as chair of the Capitol Region Watershed District's Citizen Advisory Committee, which has played an important role in reviewing the District Rules for Developments and Permits that were formally adopted on October 1. These new high standards represent a giant step toward preserving this area's water quality – the mission that this incarnation of the Environment Committee embarked upon when it began meeting in 1995 with the purpose of addressing the poor condition of Como Lake.

During the annual Spring Parks Clean-up, committee members got into canoes and trudged along the shoreline to remove trash from the lake. In mid-June, we participated in the CRWD-sponsored Como Lake Water Festival with committee displays and a tree trek highlighting some of the special species around the lake.

Other summer activities included two evening work sessions assisting Parks' Eco Partners in weeding native plantings along the Como lakeshore. Two committee members continue to attend quarterly meetings of the Shoreland Vegetation Management Task Force with Parks staff.


Autumn drew us all back to the Como woodlands to resume battle with the persistent invasive buckthorn. We collaborated with Eco Partners on two productive buckthorn "busts" in October; over 100 volunteers turned out on the 28th! We're wrapping up a bird survey of the Park and planning a woodland habitat analysis.

As an outgrowth of the committee's woodland work over the past several years, Deb Robinson came up with the Como Woodland Restoration & Outdoor Classroom Project, designed to demonstrate the educational potential of a preserved urban woodland for visitors of all ages and interests. Deb deserves a huge round of applause for all of her hard work on this exciting new endeavor! Contact her at dmrobinson@bitstream.net to learn more about it.

Ideas for new activities in 2007 include: participation in the CRWD's Como Lake volunteer water sampling program and the Ramsey County Birding Festival; Park tree mulching; residential buckthorn removal; maintenance of the Lakeside Pavilion garden; and an educational outreach program with speakers on topics such as the Como shoreland restoration, shallow lake ecology, and Como Park birds.

On a personal note, after 11 years on the committee including several as chair, I will be leaving the committee at the end of this year. It has been enormously rewarding to witness how much a small group of citizens can do to improve the environment, and I would like to express my gratitude to everyone who participates. Many thanks to you all!

Fall Pet Wellness Check

We are partnering with U of M vet students to come to seniors' homes to do a pet wellness check.

Circle of Friends Group

A fun, supportive, and informational gathering for seniors. Meets the 1st and 3rd Friday of every month at St. Timothy Lutheran Church. A new schedule is made for every 5 months and mailed out. Cost is \$7.50 per person for van transportation and 5 month membership or \$5.00 for five month membership only. The van will pick up between 1:30 P.M. and 2:00 P.M. Membership is limited to 15 people. Group runs September to June.

Exercise/Enrichment Group

Meets the 2nd and 4th Wednesday of every month at United Church of Christ in Falcon Heights. Transportation is provided. The group meets from 2 P.M. to 3:15 P.M. The Arthritis Foundation is collaborating with the Como Park LAH/BNP to conduct this Arthritis Foundation PACE (People with Arthritis Can Exercise) Program. The leader has been trained in leading exercise in range-of -motion, muscle strengthening, and endurance-building activities. Cost is \$7.50 for transportation and 5 month membership. The cost is \$5.00 for 5 month membership only. Membership is not limited and all individuals are welcome. Exercise group runs September to June.

The Gathering Respite Care Group

Here are just some of the highlights from 2006:

Our *fifth annual garage sale* was a hit; there were thousands of visitors at over 100 advertised garage sales. This event continues to be a great opportunity for bargain hunters to find diamonds in the rough, and for participants to sell those extra items cluttering up a closet or garage – and make some cash on top of it!

The annual *Neighborhood Cleanup*, "cleaned-up" once again! This joint effort between Falcon Heights, St. Anthony Park and Como Park has been a great success for many years. It continues to offer residents a lower priced, environmentally friendly way to clean out your house and garage. We'd like to thank Boy Scout Troop 285 and over 60 neighborhood volunteers for all of their help, both at the Fairgrounds and doing senior citizen pick-ups. Thank you!!

The *Lao Family Soccer Festival* event has grown to be much more than a soccer tournament and is a successful, enjoyable event for all involved. Saint Paul residents and businesses welcomed and enjoyed the lively festivities and celebrated the diversity this event continues to bring.

National Night Out celebrations were held throughout the neighborhood. This year the district council supplied 12 first-time party packs for block parties and distributed over 80 gift bags for children. District 10 worked with Northwest Como, the Saint Paul Police and Fire departments, and the Jacob Wetterling Foundation on an event at Northwest Como Rec Center, which included food, games, fun family activities and visits from the fire and police department. In spite of torrential rains it was great to see so many families enjoying the evening and getting to know their neighbors! The District 10 Environment Committee has been very busy this year. The committee sponsored two successful buckthorn removal events, a Como Lake shoreline cleanup and cosponsored the Capitol Region Watershed District Water Festival. Committee member Chet Mirocha led several Tree *Treks*, free tree identification tours. The annual parks cleanup inspired families, board members and area students to get out in the park to pick up all the garbage left on the ground from the previous winter.

As we enter 2007, *neighborhood planning* continues. As Como Park grows, there will to be items of interest, which the District 10 community will want to address. If you or your neighbors have ideas, concerns and/or comments about something happening in our community, please don't

hesitate to contact our office and get involved in the planning processes shaping our neighborhood and city.

Thank you to all the community members who participated in the neighborhood meetings concerning neighborhood issues which had arisen previous years during the State Fair. This year, your District 10 council took the lead in creating solutions to problems with licensing and locations of vendors during the "Great Minnesota Get Together." In 2006, neighborhood parking problems, vending issues and associated concerns during the Fair were significantly re-duced, and solutions to previous problems were addressed.

The *community council* played an active role in planning and coordination of events and activities in 2006. Regular monthly meetings were held as well as a few special ones: State Fair issues of parking and vending were discussed, oneside of the street parking was sought and implemented for the Street Rod Show and the district council continues as part of the Job Corps Neighborhood Advisory Committee (NAC). The *executive committee* also assisted with a major neighborhood distribution of blue recycling bins.

As you can see it has been quite an eventful year. *None of this would be possible* without our fabulous staff, board members and volunteers. But most importantly, it is the help and input from community members that makes the difference. The District 10 Como Community Council is a non-profit enterprise. We are only funded by small grants, city reimbursement and donations. Without your help in these difficult economic times, our continued outreach will be limited. As Tom Brokaw is quoted as saying, "It's easy to make a buck. It's a lot tougher to make a difference." Any donation helps and is most greatly appreciated.
